<u>THE WIDOWS TAX</u> - Under current law, survivors of deceased military members must forfeit part or all of their purchased Survivor Benefit Plan (SBP) annuity when awarded the VA's Dependency and Indemnity Compensation (DIC). The loss of any portion of the SBP annuity is known as the "Widows Tax."

The Fiscal 2020 National Defense Appropriations Act changes this provision, for the benefit of more than 65,000 military survivors, with fix that will be phased in over a three-year span. Below, find out how MOAA has fought to end the widow's tax, what's next for survivors after the repeal, and how you can get involved.



The **Senate on Tuesday voted to repeal the "widows tax,"** a financial penalty affecting over 65,000 military survivors across the country. The measure passed as part of the fiscal year 2020 National Defense Authorization Act (NDAA).

The House voted to repeal the widows tax Dec. 11. The measure now heads to the White House for President Donald Trump to sign. In a tweet on Dec. 11, Trump indicated he would sign the bill. "Congress – don't delay this anymore! I will sign this historic defense legislation immediately!"

"Because of the momentum we built, this is the year, this is the day we will finally honor the commitment made to these families who have given everything to our country," Jones said in remarks on the Senate floor prior to the Senate passing the legislation 86-8. "This is the year, this is the day that we will let our actions speak louder than words. This is the year we finally put our money where our mouth is when it comes to honoring our service members and their families. This is the year, this is the day that we finally repeal the widow's tax once and for all."

MOAA President and CEO Lt. Gen. Dana Atkins, USAF (Ret), said of the news, "This will be the culmination of the efforts of many over the last four decades: military and veteran service organizations, the media, an amazing army of surviving spouses, The Military Coalition, and members of Congress and their dedicated staffs."

MOAA has fought for years to eliminate the widow's tax. In April, more than 150 members from across the country came to Washington, D.C. as part of MOAA's Storming the Hill event. Eliminating the widow's tax was a main topic of discussion for MOAA stormers.

The final bill language phases out the widow's tax over three years, with survivors receiving their full benefits on Jan. 1, 2023.

Survivors who received a partial refund of their sponsor's premiums will not be required to return that money to DoD.

The bill language removes the option for an eligible surviving military spouse to establish an annuity in the name of a dependent child instead of their own. This change would take effect Jan. 1, 2023. Spouses who've elected to transfer their annuity payment to a child (or children) will have their eligibility for the benefit restored on Dec. 31, 2022, "whether or not payment to such child subsequently was terminated due to loss of dependent status or death," per the legislation.

Previously, survivors were coerced to transfer their survivor benefits to their children in order to receive both benefits. Those benefits expired whenever the dependent reached the age of majority. But a change in the 2017 tax bill dramatically increased the rate those benefits were taxed at.

By repealing the child option, survivors both avoid what's been termed the "kiddie tax" and receive the full benefits they deserve. Though a kiddie tax solution was not presented in the NDAA, there is a provision in the government funding deal that would eliminate this egregious tax. Congress could vote on this measure in the coming days.

MOAA NAMED ONE OF THE HILL'S TOP LOBBYISTS FOR 2019 - For the 13th year in a row, the Military Officers Association of America (MOAA) was named one of the top lobbyists for 2019 by The Hill, a news outlet based in Washington, D.C., covering federal policy, defense, finance, and technology.

MOAA is the only military or veteran service organization honored among the 100 winners in the association category of The Hill's Top Lobbyists for 2019 list.

"We are grateful to receive this recognition. Our staff and MOAA members, along with our Board of Directors and the nearly 400 chapters across our nation, take pride in our advocacy for those who serve or have ever served in our seven uniformed services, their families and survivors," said MOAA's president and CEO, Lt. Gen. Dana Atkins, USAF (Ret). "To be included among the other 99 accomplished associations adds to this honor and highlights the diversity of effort it takes to make a difference in Washington D.C."

Below are some highlights of MOAA's successful advocacy efforts in 2019, many of which are included in the Conference Report of the FY2020 National Defense Authorization Act passed overwhelmingly by the House and Senate and is now being sent to President Donald Trump for his expected signature:

- Helped secure repeal of the widows tax to eliminate the loss of up to \$12,000 per year for nearly 67,000 surviving spouses of servicemembers killed in service or through service-caused illnesses.
 This rights a wrong that has existed for over four decades.
- Partnered with other Veteran Service Organizations to pass the Blue Water Navy Vietnam Veterans
 Act of 2019 increasing access to benefits and healthcare for those impacted by Agent Orange at
 sea further from the mainland.
- Ensured a 3.1 percent active duty pay raise, and protected housing allowances from arbitrary cuts.
- Successfully lobbied Congress to delay DoD's plan to eliminate 18,000 military medical billets and
 call for an assessment on military medical readiness and support to beneficiaries, including many
 military caregivers and their families.
- Engaged Congress to legislate significant improvements to accountability for the quality and safety of military family housing provided by public-private partnerships.
- Ensured no new healthcare access fees for currently serving and retirees.

This honor really speaks to the hard work of MOAA's staff and its members, and it validates the value of relationships we forged with members of Congress and their staffs. Our work with The Military Coalition and other organizations must also be recognized as a force multiplier for all of us who lobby on behalf of those who selflessly serve our nation.

THIS IS THE 2020 VETERAN DISABILITY PAY RAISE - This article by Jim Absher first appeared on Military.com, the premier resource for the military and veteran community.

Standing by for that annual cost of living increase for your Department of Veterans Affairs disability pay? Wait no more. Officials have just announced exactly how much disabled veterans can expect those monthly disability payments to go up for 2020.

Disability compensation rates are going up 1.6% for 2020. So, what does that mean for you? More cash.

Here's Your Annual Veteran Disability Payment Increase - An increase of 1.6% does not seem like much, but it does add up over time. For example, a veteran who has a disability rated at 10% from the VA will see their monthly tax-free payment increase from \$140.05 to \$142.29, an increase of \$26.88 annually.

On the other end of the spectrum, a veteran rated as 100% disabled with two dependents will see their payment go from \$3,437.10 to \$3,492.09, or a \$659.88 annual change.

<u>HONORARY PROMOTIONS FOR 2 HERO PILOTS PART OF NDAA PASSAGE</u> - Two heroic pilots – one a member of the legendary Tuskegee Airmen, one a participant in the <u>Doolittle Raid</u> – have been recommended to the president for honorary promotions for their distinguished service thanks to the recent passage of the National Defense Authorization Act.

Col. Charles E. McGee, USAF (Ret), has been recommended for promotion to brigadier general, and Lt. Col. Richard E. Cole, USAF (Ret), would be posthumously promoted to colonel. The measure, which was signed by President Donald Trump on Dec. 20 and includes several MOAA-backed provisions, recognizes the aviators' service in air operations during World War II.

"Beyond expectations," said McGee, a MOAA Life Member, describing the promotion. He celebrated his 100th birthday on Dec. 7; the day before, he flew a private jet from Frederick, Md., to Dover AFB, Del. He told MOAA he was planning a quieter celebration of the promotion with family and friends.

McGee, of Bethesda, served with the Tuskegee Airmen, the first African American aviators to serve in the thensegregated armed forces. The nickname came from Alabama's Tuskegee Army Airfield, where they trained.

The group included fighter and bomber pilots that completed combat missions in Italy during World War II.

McGee is a legend among Air Force aviators for flying 409 fighter combat missions over three wars. He completed 136 combat missions with the Tuskegee Airmen during World War II, 100 combat missions in the Korean War, and 173 combat missions in the Vietnam War.

McGee told MOAA it was rewarding to take on different phases of missions in each of those wars: superiority-type flying during World War II, interdictions and ground support in Korea and intelligence-gathering in Vietnam. However, he said his most rewarding experience was to retrieve Americans during World War II, which had been part of classified missions he said he couldn't share until years after.

"Retrieving Americans protected by Yugoslavia from German forces was important," McGee said. "It was highly classified. It was never talked about. Fortunately, two of those missions, our unit was able to participate in. It was always, to me, very important to have participated in such an adventure that brought a lot of Americans back home."

McGee became the first African American man to command a stateside Air Force Wing and Base. He retired after serving 30 years.

Doolittle's Co-Pilot - Cole had been the last surviving Doolittle Raider – the nickname given to the fearless aviators who executed an air raid on Tokyo and other places in April 1942 to strike back at Japan after the attack on Pearl Harbor.

Cole, a MOAA member who was 103 years old when he died in April, first enlisted as an aviation cadet, then earned a commission as a second lieutenant to become a pilot. He retired in 1966 after serving 26 years in the Air Force.

<u>VETERANS WITH MESOTHELIOMA</u> - Quick Summary - Veterans make up one-third of all patients diagnosed with mesothelioma. Each military branch used asbestos until the 1980s, putting veterans at risk of the disease. Veterans today have many resources to help them get the treatment they need. Asbestos manufacturers hid this information from the government to continue selling their products. Eventually, OSHA began implementing limits on <u>asbestos exposure</u>.

Protective equipment like respirators became standard. The military also systematically phased out asbestos and replaced asbestos-containing materials with safe products. However, it was virtually impossible to eliminate all asbestos in the military, as it was used too widely.


