#### **Old/New Business:**

## > ROTC/JROTC MOAA Leadership Awards:

- Larry Stawicki is getting contact information together and does not expect this program to take on a need for assistance until the April/May time frame. We have 39 high schools this year. Awards have been ordered.
- Scott is getting the bars/Velcro patches and awards together for the Army. Chuck is working on the Air Force.
- > <u>JROTC Scholarship</u>: Scott Morris advised that he has been receiving scholarship applications and we will be able to provide up to seven awards this years. As in past years, we will also be considering students who will be attending two year schools.
- > Due to a lack of interest, we will not be doing any more CPK fundraising.
- Ron Morgan advised that he will be reapplying for the MOAA Military Family Initiative (MFI) Grant. We currently have 14 Mentors and Mentees. With the grant we have been paying for the lunches of new mentees at the Veterans Bridge Home Luncheons/ Networking Sessions.
- > We will be applying for the Harris Communications Award and it is due 1 March.
- > Following discussion of the website and the unknown costs of the current web we are using Scott moved that we go back to the old website, Carol seconded the motion and it was approved. Ron Wilsbach will contact the old webmaster and get the things moving for us. In addition of a known cost, this has the additional benefit of getting access to our archived information.
- Ron Morgan and Carol Aljets have volunteered to review our current By-laws for possible changes. Scott Morris has already updated the section relating to scholarships.
- > Application has been sent for the \$300 USAA grant.
- > Ron Wilsbach presented the proposed budget for 2019. Ron Morgan moved the budget be approved, Scott Morris seconded and the motion was approved.
